St John's Wort 1.8g: More than Just Mood

St John's Wort herb has been used traditionally for more than 2000 years. In the mid-1980s many clinical trials in Europe and throughout the world began exploring the effectiveness of St John's Wort extracts.¹ Extracts in the 1990s were standardized to contain a certain amount of hypericins (hypericin and pseudohypericin) and hyperforin. In more recent years, hyperforin has been considered less important (due to its potential instability), and the flavonoids have gained in importance.^{*}

- by promoting healthy activity in some central neurotransmitters and pathways (encourages healthy functioning of nerve impulses in the brain)¹²

What is a nerve tonic?

For temporary mood swings nerve tonics may help restore balance and support a healthy response.^{13,14*}

The American College of Physicians–American Society of Internal Medicine prepared a clinical guideline in 2000. They recommended that St John's Wort may be considered as short-term support for temporary mood swings. They cautioned that St John's Wort is not approved by the US Food and Drug Administration and that preparations may vary substantially from those tested in clinical trials.¹⁵ The quality of St John's Wort products sold in the United States has been found to vary greatly. Research published in 2005 and 2006 indicated that products obtained from Mississippi and Washington DC had levels of the important plant constituents called hypericins at much lower than that claimed on the labels.^{16,17*}

What Makes St John's Wort 1.8g Unique

St John's Wort 1.8g is unique in the professional herbal products industry because:

- It states on the label exactly how much each tablet contains of the important plant constituents (hypericins, flavonoid glycosides)
